- 1. This permit is subject to valid Liability and Property Damage Insurance Coverage for the duration of the permit, and applicant must provide proof of such insurance:
 - Carrier to hold Public Liability and Property Damage Insurance for \$2,000,000 for single occurrence and \$5,000,000 for general aggregate.
 - The carrier will be liable for any damages that may occur as a result of the move(s) to public or private property.
- 2. This permit is subject to all applicable and updated conditions set by the Highway Traffic Act and/or specified in: "A Guide to Oversize/Overweight Vehicles and Loads in Ontario" (available on line at: http://www.mto.gov.on.ca/englisht/trucks/oversize-overweight-manual.shtml).
- 3. This annual permit does not apply to moving loads that exceed weight restrictions on specific town roads that have load restrictions. The updated map of town roads with load restrictions can be found on the Town of Oakville website at: Heavy Truck Prohibitions and Restrictions Map.
- 4. The applicant will satisfy themselves as the suitability of the approved route for the proposed movement. No representations are made by municipal authorities as to the clearances and capacities involved therein.
- 5. If it is necessary to cross sidewalk with the load mentioned herein, the applicant will cover said sidewalk with 4" planking.
- 6. The applicant, their heirs, executors, administrators and assigns will indemnify and save harmless the Town of Oakville from any claim, action, damage or loss whatsoever, arising from operations carried out under this permit.
- 7. The Town of Oakville reserves the right to cancel its permission at any time without notice.

All movements limited to hours of 9:30 a.m. to 3:30 p.m. and 8:00 p.m. to 6:00 a.m. No movements on Sunday or Statutory Holidays. This permit cannot be used to move objects that exceed any of the above mentioned limitations. If required, a "Single Trip Permit" should be obtained.
