

Application for Appointment – Municipal Law Enforcement Officer For Private Property Parking Enforcement

The following persons may apply to the Town of Oakville for an appointment as a Municipal Law Enforcement Officer for private property parking enforcement:

- 1. A person employed by a private property enforcement company;
- 2. A person employed by a property management company; or
- 3. A person designated by a commercial property owner or condominium board to enforce parking on their private property.

The application form:

- Applicants employed by a private property enforcement company must complete Section A, Section C, Section D, and sign Section E.
- Applicants employed by a property management company must complete Section A, Section B, Section D, and sign Section E.
- Applicants who are designated by a commercial property owner or condominium board to enforce parking on private property must complete Section A, Section D, and sign Section E.

All applicants must provide the following supporting documents:

- Digital Photograph: must be clear, sharp and in focus, show the applicant's full face and shoulders straight on and squared to the camera, and show how the applicant looks at the time of application.
- Criminal Record Check: provided by an accredited Canadian Police Service or by a third party approved by the Town of Oakville that is no more than 90 days old at the time of application. You are responsible for the cost of obtaining a criminal record check.

Multiple addresses may be included on the same application form as long as the properties have the same owner. If an applicant is applying for an appointment to enforce parking at properties owned by different owners, a separate application form must be submitted for each property.

Applicants must sign and date the application form and submit it and the supporting documents to parking@oakville.ca

A Private Property Authorization form must be submitted by the property owner prior to processing your application form. Processing your application will take approximately 14 days. Once your application has been received and reviewed, you must successfully complete a training program. You will be contacted by enforcement staff to schedule training.
