A mandatory pre-Parade meeting will be held on <u>Wednesday</u>, <u>November 13, 2024 at 7 p.m.</u> in the Atrium at Oakville Town Hall (1225 Trafalgar Road).

A designate representing your band must attend this meeting. New and returning bands must arrange for a representative to attend the meeting. Failure to attend this meeting will result in your band being disqualified. No exceptions.

At this meeting all Parade entries will receive their Final Information Package which includes information about Parade line-up, new initiatives, and access and disbursement areas.

Participant regulations, terms and conditions

In signing and returning this application form, all parties understand and agree to the following participant regulations, term and conditions.

All participants

- The band agrees to supply the Town of Oakville with live/recorded band music for the Oakville Santa Claus Parade being held on Saturday, November 16, 2024, in the Town of Oakville.
- The Band agrees to play music for the duration of the Parade, expected to last approximately 1.5 hours.



- The Band and the Town of Oakville agree that in return for the Band's performance, the Town shall pay the Band a fixed price for all services rendered. The parties agree that there can be no extras or additions to this amount.
- All music must be Christmas/holiday in nature.
- All entries must complete the Media Information Outline included above.
- All participants in the Parade shall not consume or give the impression of consuming alcoholic beverages during the Parade.
- Any entry may be refused entrance into the Parade at any time, should the entry not meet Parade guidelines or differ from its approved entry form.
- Insurance Coverage The Town of Oakville and the Santa Claus Parade have arranged, at its cost, insurance coverage for the Parade participants and their entries under the Town's Liability Insurance Policy. It is strongly recommended that your group arranges its own insurance for a minimum of \$2 million commercial general liability coverage.
- Photo Permission We hereby grant the Oakville Santa Claus Parade Committee and the Town of Oakville the right and permission to use any and all pictures and film footage of our band/group for the purpose of promoting the Oakville Santa Claus Parade.
- No Santa Claus or Mrs. Claus replica may be a part of any entry other than the Official Santa Claus Parade Float.
- I/we understand that no vehicles are to accompany the band on the Parade route.
- The Parade is a smoke-free environment. Smoking during the Parade is prohibited.
- Handouts and give-a-ways are not permitted.
- No entry will distribute literature, pamphlets, leaflets, brochures, flyers, or any other written or printed advertising to spectators.
- There will be no premature exiting of the Parade route.
