
Public Engagement Opportunity

Saville Area Stormwater System Improvement Study Preliminary Proposed Stormwater Management Pond at Seabrook Park

Time: May 8th, 2024 from 6:30 pm to 8:00 pm Meeting Location: Seabrook Park Playground



Study Overview

The Town of Oakville has initiated a study in the Saville Neighbourhood Area to identify drainage deficiencies and to explore opportunities for stormwater system improvements. Preferred options to improve drainage and reduce the potential for flooding will be proposed.

This study is being undertaken as a Schedule B Project under the Municipal Class Environmental Assessment (EA) Process, approved under the Ontario Environmental Assessment Act.

Preliminary Preferred Solution at Seabrook Park

A component of the preliminary preferred solution is a stormwater management pond within Seabrook Park. The proposed pond includes a permanent pool of water with natural surroundings planted with

a mix of trees, shrubs, perennials, grasses, and aquatic vegetation on gentle slopes. The existing playground and baseball diamond can continue to be park features in conjunction with the stormwater management pond.
